



KINGSTON DISTRICT FIRE DEPARTMENT YOUTH FIREFIGHTER INFORMATION

1. Training will be one night a week, specifically for the youth program
2. Training will be from 1830-2030, day of the week TBD
3. Participants are not expected to supply any gear
4. Ages for this program are 16 – 17 years old
5. Training will consist of the National Fire Protection Agency Level 1 Firefighter training (Qualification not Certification). Some of the Topics will be:
 - a. History of the fire service
 - b. Fire Hoses
 - c. Personal Protective Equipment (PPE)
 - d. Self Contained Breathing Apparatus (SCBA)
 - e. Ground Ladders
 - f. Ariel Operations
 - g. Pump Operations
 - h. Hand Tools
 - j. Motor Vehicle Extraction Tools (Jaws of Life)
 - k. Hazardous Material (HAZMAT)
 - m. Communications
 - n. Ventilation
6. Program will consist of 10 members in 2025-2026
7. The youth program will be one school year long.
8. Completed Applications can be Dropped off at the Hall Monday nights, from September to June between 1830 and 2100. Saturday mornings between 0900-1100 in July. Applications can also be dropped off at the Kingston Village Office.
9. Deadline for applications is August 1st.
10. Only successful applicants will be notified by August 20. All other applications will be held for one year and new members may be added throughout the year.



KINGSTON DISTRICT FIRE DEPARTMENT YOUTH FIREFIGHTER PROGRAM RULES

1. Personal Protective Equipment (Department Supplied). will always be worn during training.
2. If you are cleared to respond to the hall during an emergency, there will be no responding during the hours between 0000-1500.
3. There is a zero tolerance for alcohol and/or intoxicating substances.
4. There will be no smoking/vaping while at the hall or during training.
5. Respect will be given to all members of the program and any Firefighter assisting with the training.
6. Zero Tolerance for harassment or abuse (Physical/Verbal).
7. Members shall not willfully neglect or refuse to obey any proper order or supervisory direction of a training firefighter.
8. Members shall not show willful disregard for the community.
9. Members shall observe a proper Chain of Command, recognizing the authority of any member placed in a temporary position of command or supervision.
10. Members will not be involved in the inappropriate use of social media venues as per Appendix C of the Kingston District Fire Department Policy.
11. Members will not be a party to inappropriate discussion of responses/incidents in a social setting.
12. Attendance shall be kept above 60% of training. Attendance will be reviewed every three months. If a members numbers fall below the 60% a meeting with the member and three of the youth Firefighter Program committee.
13. By Signing the application and liability waiver you agree that you have read and agree to these rules.
